Portfolio Construction

The 2020 Fund initially sought to invest 70% of its assets in equity mutual funds and 30% of its assets in fixed-income mutual funds. The Fund has maintained such an asset mix, until approximately 10-12 years from the stated target date. Starting 10-12 years from the target date, the Fund began seeking to reduce risk on a periodic basis by adjusting the Fund's ratio of equity to fixed-income mutual funds downward as the target date approaches. Upon reaching the target date, the Fund will seek to achieve an asset allocation of 30% equity mutual funds and 70% fixed-income mutual funds.

Investment Philosophy

The StarPath Funds® investment philosophy is based on the following core beliefs for equity investing: Diversification reduces risk; Markets are efficient; Asset allocation is the key determinate of portfolio returns; Passive management is superior to active management; Asset class investing is superior to indexing. Rogers' core beliefs for fixed-income investing include: Invest in high-quality, investment grade fixed-income securities and Keep durations and maturities short to intermediate.

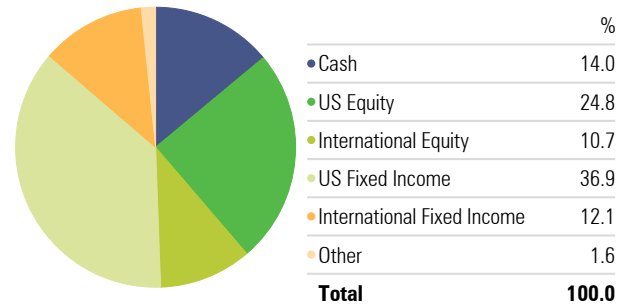

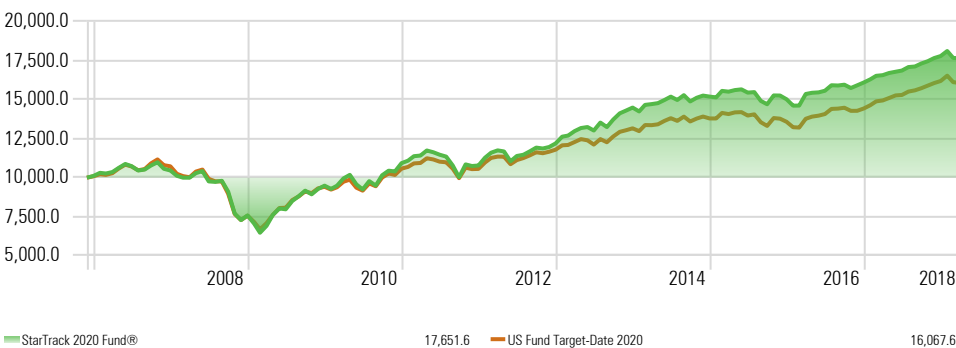
StarTrack 2020 Fund® - Asset Allocation (US)
