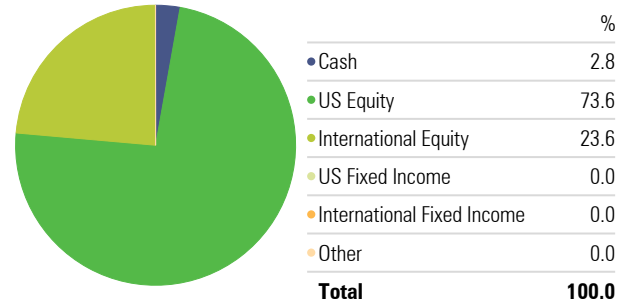

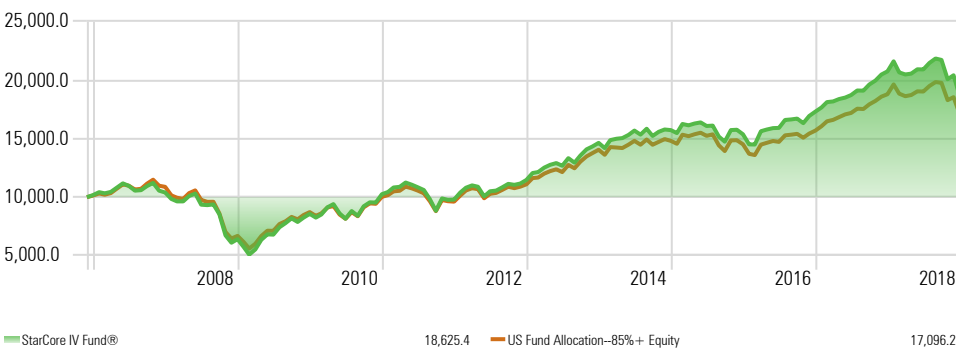
StarCore IV Fund® - Asset Allocation (US)
