The Fund will primarily invest in domestic value, international value, and emerging markets value mutual funds. The Fund will strive to increase potential expected long-term returns by favoring value over a more traditional "blended" markets or growth-oriented approach. 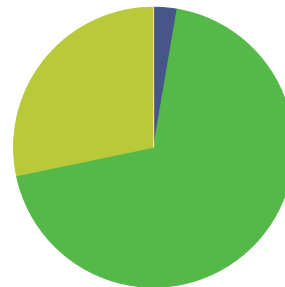

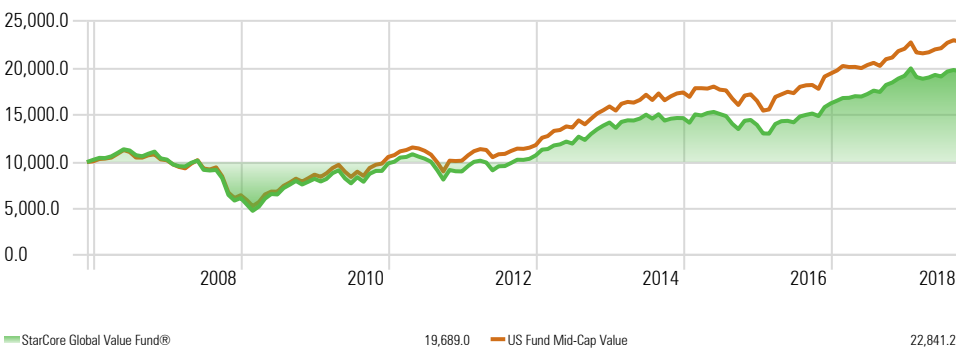
