Under normal circumstances, the Fund will invest up to 98% of its assets in equity mutual funds. The Fund will seek to diversify amongst all market capitalizations and styles, with the intention of gaining the potential benefits of investment opportunities outside the U.S. and Canada.

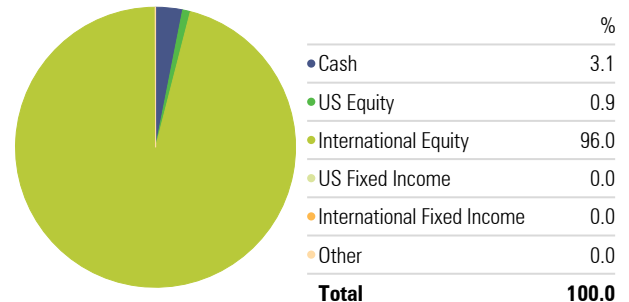

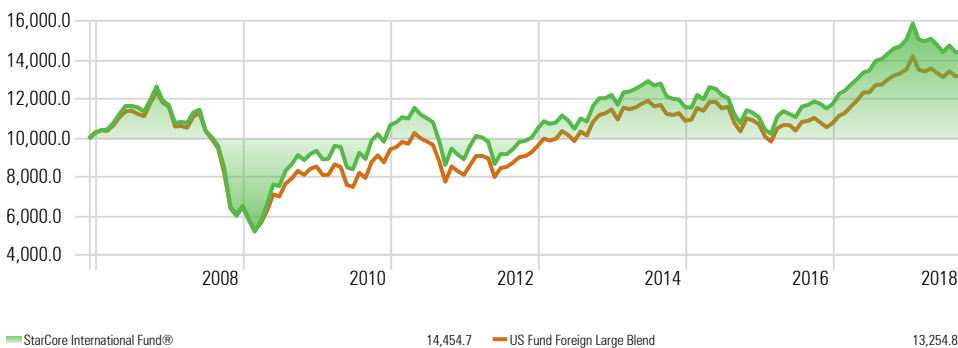
