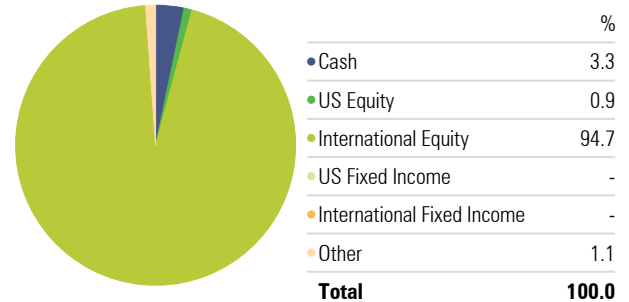

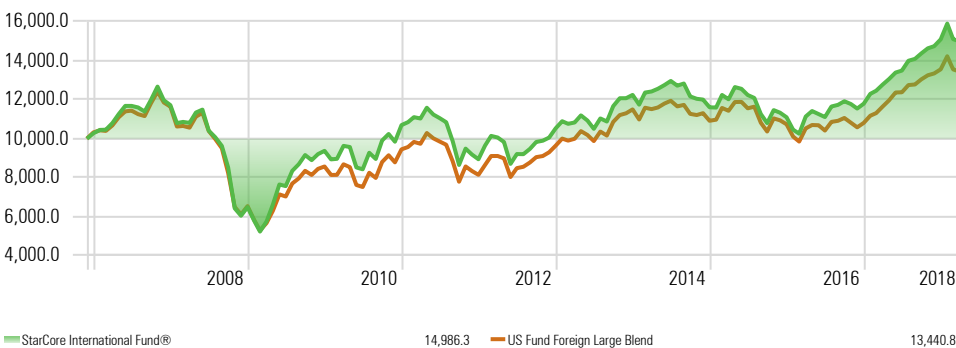
## StarCore International Fund® - Asset Allocation (US)
